

Chair's Annual Report for the period 1 January 2022 - 31 December 2022

Summary

The CIAN Committee made the difficult decision to reduce the resources provided to members this year, due to a reduced number of Committee members. We no longer provide a quarterly newsletter via email, but we do offer regular news updates via our website which is promoted on our social media channels. We have also reduced the number of Network Meetings. We urgently require new Committee members to enable CIAN to continue to provide vital internal audit resources for our members.

Objectives, Activities, Achievements and Performance against the 2021 - 2025 strategy

The objectives from CIAN's 2021 - 2025 strategy are to:

1. Raise the profile of internal audit in the third sector

CIAN's social media presence increased by 165% on LinkedIn in 2022, to a total of 337 followers. Twitter increased by 21% to a total of 105 followers.

We promoted Internal Audit Awareness Month in May, which gained 384 post impressions.

2. Provide CIAN members with opportunities for professional development

CIAN held one training day at the London office of Grant Thornton with 18 attendees from our membership. The training was provided by John Chesshire, on the subject of the Assurance Framework.

We promoted five job vacancies within the charity sector on our website and social media pages, and promoted our CIAN Committee Treasurer vacancy.

We secured free membership to the Chartered Institute of Internal Audit's Data Analytics Forum for CIAN members, with thanks to Derek Jamieson at the Chartered Institute of Internal Auditors.

3. Share resources that promote best practice and support effective internal audit

We provided the following presentations and resources to support effective internal audit during our Network Meetings:

We promoted Charity Fraud Awareness Week 2022, which has a wealth of resources to help charities raise awareness of fraud, which supports the work of internal auditors.

4. Provide opportunities for networking amongst members

CIAN held three Network Meetings in 2022, with over 35 attendees at each session. We have decided to continue to host both online and in-person Network Meetings because online meetings are more inclusive of our members across the UK. Two of our Network Meetings were held online, and our AGM was held in-person, hosted at the London office of Crowe.

The Small Audit Function Special Interest Group held one meeting on Quality Assurance and Improvement programs with Liz Sandwith as their guest speaker. The Retail Special Interest Group held one meeting, with topics such as energy efficiency checks and fraud prevention.

CIAN membership increased by 5% during this period, to a total of 199 members.

Financial Position and Reserves Policy

As recorded in CIAN's 2022 accounts, our available funds as at 31 December 2022 were £9704. Suggestions from members for use of these funds are welcome.

CIAN's ability to continue to provide free network meetings and heavily discounted training remains reliant upon five large firms: Sayer Vincent, BDO, Crowe, Haysmacintyre and Grant Thornton, who generously support us by providing free venues and refreshments for our meetings and training events. We are very grateful for their support. It is also important that we thank our speakers at our Network meetings who give their time freely.

CIAN does not have any debts and, thanks to the generosity of the firms noted above, our fixed costs are limited to expenditure on our website and domain. Our reserves policy is to maintain a balance of at least £3,000 to ensure that we would be able to cover incidental costs and upfront payments required to run CIAN training courses.
